INTEREST OF AMICI

Since its founding as the Kansas State Teachers' Association in 1863, the Kansas National Education Association ("KNEA") has existed for "the support and promotion of the general educational interests of the State of Kansas; the collection and dissemination of educational intelligence; and the mutual improvement of its members in all that pertains to the teacher's vocation." (CHARTER OF THE KANSAS STATE TEACHERS' ASSOCIATION, Section II [December 28, 1876]) One hundred and fifty years later, these continue to be the guiding principles of KNEA. (KANSAS NEA CONSTITUTION, Article II [2013]).

Today, KNEA continues to be a voluntary, statewide organization that is made up of over 24,000 members from every part of the education profession. KNEA's mission, however, remains little-changed since its founding: "to empower its members to promote quality public schools, strengthen the teaching profession and improve the well-being of members." (KNEA Mission Statement.)

KNEA recognizes that the quality of Kansas' education system is inextricably dependent upon the amount of funding that it receives from the legislature. KNEA's abiding interest in ensuring quality education for the children, youth, and adults of Kansas compels its interest in the outcome in this case.

ARGUMENTS AND AUTHORITIES

KNEA is a voluntary association of Kansas' education professionals. Under its constitution, KNEA is required to pursue a program that emphasizes quality education for the children, youth, and adults of Kansas. (KANSAS NEA CONSTITUTION, Article II [2013]). KNEA is authorized to do this through a variety of methods, two of which are relevant here. *Id.* First, because KNEA believes that quality education in Kansas is impossible unless the legislature fulfills its constitutional duty to provide the funding necessary for a quality education program, KNEA must do what it can to ensure adequate financing of public education in Kansas. *Id.* Since the 3-year school-funding plan enacted by the legislature in response to the Court's *Montoy* decision ended, the legislature has failed to meet its constitutional burden to adequately fund Kansas' schools.

Number of Teachers Employed Statewide As a Measure of Suitability of School Funding

Certainly, one factor that affects the quality of education for the children and youth of Kansas is the number of students a teacher is assigned in class. This student-to-teacher ratio is reflected in the number of teachers that school funding enables school districts to employ. As measured by the number of teachers employed in Kansas and the ratio of students per teacher, the legislature has failed to constitutionally fund Kansas' education system since the monies appropriated under the 3-year post-*Montoy* school funding plan expired.

Education statistics, including the number of teachers employed and the student/teacher ratio by state, are compiled and maintained by the National Center for Educational Statistics (NCSE). The NCSE has posted these and other statistics on its website in a document titled

Public Elementary and Secondary School Student Enrollment and Staff Counts from the Common Core of Data for the relevant school years through the 2010-11 school year. (http://nces.ed.gov/ccd/pub_snf_report.asp) The number of teachers employed in the state is a concern of KNEA, both because KNEA believes that educational quality generally improves with smaller class size.

The effect of the implementation and then the expiration of the 3-year post-*Montoy* school funding plan is reflected in the number of teachers employed in the state, and in the ratio of students to teachers. As reported by the NCES, during the 3 years of the *Montoy* monies, the number of elementary and secondary teachers in Kansas grew by over 5%. (*Id.*, for school years 2006-07, 2007-08, and 2008-09) This growth in the number of teachers in Kansas began to decline almost immediately upon the expiration of the post-*Montoy* funds. (*Id.*, for school years 2009-10 and 2010-11.) As of the 2010-11 school year, the last year for which the NCES has posted data, the number of teachers in Kansas had nearly reverted to the level it occupied when this Court found the legislature in violation of its constitutional duty to suitably fund education in *Montoy*.

Moreover, except for one year, the number of students in Kansas has increased each year since before the Court's decision in *Montoy*. (*Id.*, see 2006-07 school year) Consequently, by the 2010-11 school year, the student/teachers ratio in the state had reverted to the level it had been when the *Montoy* court found school funding in the state to be constitutionally inadequate. *Id.* To the extent, therefore, that the number of teachers and the student/teacher ratio in Kansas can serve as a proxy for the level of education funding in Kansas, it is currently no better than what it was when the court in *Montoy* found it constitutionally insufficient.

Teacher Pay As a Measure of Suitability of School Funding

Likewise, KNEA's constitution requires the program of KNEA to emphasize quality education for the children, youth, and adults of Kansas through working for the economic security of Kansas' educators. (KANSAS NEA CONSTITUTION, Article II [2013]). Consequently, teacher pay is an important interest of KNEA. Like the number of teachers in Kansas, teacher pay is, at best, an incomplete measure of the adequacy of school funding. However, the level of average teacher pay is an evidence of the suitability of the legislature's funding of education in Kansas. Like the number of Kansas teachers, Kansas average teacher pay shows that teachers are no better off than they were when the court in *Montoy* found school funding in Kansas to be constitutionally inadequate.

Dr. Wade Anderson, KNEA Director of Negotiation and Research, has analyzed the Kansas teacher average salary for school years since the 1991-92 school year. (KNEA Negotiation and Research Report on 2011-12 Actual and 2012-13 Contracted Teacher Average Salaries, Supplementals, and Fringe Benefits in Kansas Unified School Districts, attached as Appendix.) Dr. Anderson's research and calculations show that, while the Kansas teacher average salary, in terms of real dollars, has grown steadily since the 1991-92 school year, its growth rate has lagged both that of U.S. per capita income and Kansas per capita income. (*Id.*, at p. 1)

Furthermore, Dr. Anderson's research shows that the Kansas teacher average salary has remained stagnant since at least the 1991-92 school year, when considered in terms of constant dollars. *Id.* The only deviation from this trend coincided with the legislature's implementation of the 3-year school funding plan enacted following this Court's decision in *Montoy*. *Id.* Once the 3-year post-*Montoy* school funding plan was abandoned, the Kansas teacher average salary,

in terms of both real and constant dollars, fell. *Id.* For the 2011-12 and 2012-13 school years, the “Kansas teacher average salary” in terms of constant dollars had fallen below that of the 1991-92 school year, and it was comparable to the level it was when the court in *Montoy* found school funding in the state constitutionally inadequate. *Id.*

Research shows that an effective teacher is key to student success. (See, e.g., “Using Multiple Evaluation Measures to Improve Teacher Effectiveness,” downloaded from <http://www.americanprogress.org/issues/education/report/2012/12/18/48368/using-multiple-evaluation-measures-to-improve-teacher-effectiveness/>) Furthermore, studies suggest that having highly effective teachers can result in significant increases in students’ future earnings. (See, Hanushek, *The Economic Value of Higher Teacher Quality*, NATIONAL BUREAU OF ECONOMIC RESEARCH, Working Paper 16606, (2010) downloaded from <http://www.nber.org/papers/w16606>.) The recent effort to link teacher evaluations to measures of student progress is, in no small part, a reflection of these results. It is essential, therefore, for school districts to be able to retain highly effective teachers.

The Kansas legislature has not done what it needs to do to retain the state’s best and most highly effective teachers. Dr. Anderson’s research shows that average teacher salaries in Kansas today provide teachers no better standard of living than they had 20-25 years ago. It was only during the three years that the funding plan that the legislature enacted to cure constitutional infirmities found by the *Montoy* court that the standard of living of Kansas’ teachers rose above the nearly constant level of the last 20 years.

The legislature’s failure to maintain its post *Montoy* funding plan once again allowed Kansas’ teachers standard of living, when considered in terms of constant dollars, to once again fall back to the level it had been when the court found the legislature’s funding of Kansas education to be constitutionally deficient. The state cannot reach the goal of staffing the state’s

schools with the best and most highly effective teachers, if the most it can offer is a stagnant standard of living through their career in education. Many of the best teachers can and do go elsewhere where their economic future is brighter.

When viewed by the measures of average teachers' salary, number of teachers employed, and the student-to-teacher workload, the legislature is doing no better in funding the education system in Kansas today than it was when the court in *Montoy* found education funding to be constitutionally inadequate.

Federal Teacher Tax Deduction Revisited

In its amicus brief in *Montoy*, KNEA noted that teachers often face the choice of using their own resources to provide supplies, supplemental materials, and other necessities for their classrooms, or to do without. At that time, KNEA's national affiliate, the National Education Association estimated that the average teacher nationwide spent \$400 a year of their own money on classroom supplies, while Quality Education Data estimated that the average teacher spends over \$520 a year out of pocket. 149 CONG. REC. S5859 (daily ed. June 20, 2002) (statement of Sen. Collins).

In response, Congress provided a tax deduction for the 2002 and 2003 tax years of up to \$250 for teachers who use their own money to buy classroom materials. JOB CREATION AND WORKER ASSISTANCE ACT OF 2002, P.L. 107-147, Title IV, Subtitle A, § 406(a), (b), 116 Stat. 43 [codified at 26 U.S.C. § 62(a)(2)(D)]. Although this deduction was originally intended to extend only for two tax years, since then, Congress has seen the need to extend to teachers the deduction for subsequent tax years. Most recently, Congress did so for tax years through 2013. AMERICAN TAXPAYER RELIEF ACT OF 2012, P.L. 112-240, Title II, § 201(a), 126 Stat. 2323 [amending 26

U.S.C. § 62(a)(2)(D)]. Although thus far, Congress has treated this as a problem in need of only a short-term fix; the teacher tax deduction seems to be well used.

For Kansas' teachers, whose standard of living, as we have seen, has been stagnant since the 1991-92 school year, the burden of using their own resources to provide supplies and other necessities for their classrooms is truly an insult added to injury. The experience of Kansas' teachers abundantly supports the district court's finding that the Kansas legislature has failed to make suitable provision for finance of the educational interests of the state.

CONCLUSION

The district court, in its comprehensive decision in this case, found that the current system for funding public education in Kansas, by reason of its under-funding, violates Article 6 of the Kansas Constitution's requirement that the legislature make suitable provision for finance of the educational interests of the state. KNEA's experience supports the district court's decision. The Kansas National Education Association respectfully requests that the Supreme Court affirm the district court's decision in this case.







2011-12 Actual and 2012-13 Contracted Salaries



Distribution of 2012-13 Average Contracted Teacher Salaries Including Supplements and Excluding Fringe


