ARTICLE VII

SEPARATION OF SERVICES OF TEACHERS

A. Resignations and Cancellation of Contracts

2. Liquidated Damages

A liquidated damages fee of \$1,000 shall be required of teachers resigning after the statutory notice period set forth in Kansas Statutes Annotated [K.S.A.] 72-5401 et seq.]. Exceptions to this provision may be requested and approved on a case-by-case basis by the Superintendent or his/her designee.
