Pursuant to the allotment process as set forth in KSA 75-3722, the Division of the Budget has detailed the allotment reductions announced by the Governor on March 11, 2011, to the specific budget units as they relate to each agency. The Division of the Budget is transmitting these amounts for entry into the accounting system.

The attached spreadsheet shows the reductions for State General Fund accounts, which will bring the projected ending balance of the State General Fund to zero. Because the 2011 Legislature has failed to appropriate the funding necessary to finance anticipated expenditures for the health and human service entitlement programs managed by the Health Policy Authority, SRS, Department on Aging and JJA, the Governor cannot fully implement the allotments proposed on that date. As noted at that time, the amount of the allotment reduction for general state aid within the Department of Education has been reduced to \$859,572. Please contact our office in the event that you have questions regarding the reductions.
